Artists will be notified by phone of work not accepted. These works may be picked up after Thursday, November 1st. Entry fees are nonrefundable.

**CATEGORIES:** Digital Format Prints (not digitally enhanced photography: e.g. PhotoShop or Elements)  
Traditional FilmPrints

**Eligibility:** All entries must not have been previously shown at Gallery 53. They must be ORIGINAL – that is, your own design and composition as well as your own execution. Pictures must be framed, wired and ready for hanging. NO SAWTOOTH HANGERS. Framed work more than 42" in width accepted at discretion of selection committee. Labels must be completed, signed and accompany each piece. Each label has two parts. One half of the label will extend beyond the frame. Affix the label to the lower left-hand corner (when you are facing the back of the canvas/mat). A 35% commission will be take on sold items. No POR; NFS is OK.
